JOB DESCRIPTION

LIFEGUARD

Reports to: Marina Director

FLSA: Hourly Non-Exempt Position

Position Summary:

Implement all water safety policies and procedures. Supervise members and guests in and around the swimming pool. Knowledge of and ability to perform required role in all emergency situations.

Knowledge, Core Competencies and Expectations:

1. Adequate knowledge of and training in pool chemistry, rescue and surveillance techniques, CPR/AED and blood-borne pathogens.
2. Participates in pool safety programs and risk management.
3. Employs only those methods and teaching techniques outlined and approved by the American Red Cross.

Licenses and Special Requirements:

1. Red Cross Lifeguard Certification, AED Certification & CPR Certification

Essential Functions:

1. Performs required pool pre-opening duties.
2. Maintains amenities in and cleanliness of pool deck and playground area.
3. Place rescue tube, backboard and first aid kit in appropriate areas daily.
4. Observe swimmers at all times to ensure their safety – enforce pool rules.
5. Administers care to swimmers' minor injuries such as small cuts and bruises.
6. Maintains all necessary records determined by the Marina Director.
7. Inform Marina Director about unresolved member or guest disruptions that could cause safety concerns.
8. Straighten and clean pool area at the end of the day.

Other Duties and Tasks:

1. Attends all meetings as directed by the Marina Director.
2. Checks first aid supplies and reports needed items.
3. Performs other appropriate tasks assigned by the Marina Director.

Physical Demands and Work Environment:

1. Ability to bend, stretch, twist or reach, walk, stand, stoop, climb stairs, balance and/or crouch.
2. Physical exertion over long periods of time.
3. Push, pull and lift 50 pounds.
4. Working conditions are often, hot, humid slippery and wet.
5. Able to work in a busy, noisy environment.
6. Able to tolerate the smell of chlorine and frequent exposure to cleaning agents.
